Permanent Card Terms & Conditions

- The Card is and remains as the property of Kim Lim Australia Pty. Ltd. It is issued to you free of charge for your own usage.
- The card is issued for the use by the cardholder only and under no circumstances should that person allow others either permanent or casual to enter or exit the car park using the card.
- All cards must be returned to Kim Lim after termination of the parking with the company.
- Lost or stolen cards must be reported to the car park Manager immediately
- Each permanent parking space is marked with the occupant's car registration number. Should this registration change, please inform the Manager immediately.
- Should you pass the card to another card holder employed within your own organization please inform the Car Park Manager beforehand with the name and car registration of the other person.
- Any card that is lost or damaged will be charged at the current rate.
- Permanent parkers who have been issued with an access card are not permitted to obtain a casual parking ticket from the ticket machine for any reason, without permission. If they do so they are liable to pay casual parking charges applicable for that ticket.
- The cards are sensitive to all magnetic fields such as computers, radios, mobile phones, central locking keys, power windows and credit card. You should keep your card away from these items. In addition, it is imperative that the cardholder maintain the condition of the card. Kim Lim Aust. P/L will not accept any unintended consequential loss resulting in the card malfunctioning.
- Do not attempt to repair a damaged card with adhesive tape, as this will render the card inoperable.
- When entering or exiting the car park the card must be scanned regardless of whether the boom gate is raised. As this will ensure your entry or exit is secured.
- All permanents shall park on the ground level during weekends. Spaces will not be reserved on weekends for permanents already parking on ground level.
